The return objective of our planned giving portfolio is typically to preserve purchasing power over time as well as exceeding the predicted return rates.

COLONEL RAY FITZGERALD '60 SUPPORTS HIS CLASS PROJECT

Colonel Raymond N. Fitzgerald '60, USAFR (Ret.), was a loyal member of the Class of 1960. When the class launched a fundraising project focused on estate and life income gifts for their 60th reunion, Ray answered the call. In 2017, he documented an estate gift by making the Naval Academy Foundation a beneficiary of his IRA and became a member of the Robert Means Thompson Society. Naming the Foundation as a beneficiary of his IRA was a smart move on Ray's part—it was easy to do and it saved his family the costs of income tax on the gift. Ray died in December 2020 and we received the final gift from his IRA last year-his estate gift was over eight times the amount of his total lifetime giving. Ray's story illustrates how estate gifts help alumni and friends expand their philanthropy and solidify their Naval Academy legacy. His thoughtful gift will help support the Class of 1960 Distinguished Visiting Professor of National Security for years to come. Furthermore, the generosity of Ray and his classmates inspired other alumni, and many classes now plan to celebrate important reunions and milestones by documenting estate gifts.

In today's highly competitive world, funding through private gifts is absolutely essential to the strategic advancement of a dynamic learning environment.
